**SOME EXTRACTS FROM SECTION 24 OF MIZORAM STATE LOTTERY  
RULES, 2000**

1. Permission for conduct of Private Lottery may be issued by Director, Institutional Finance & State Lottery after obtaining approval of Government.
2. Reason for conduct of Lottery must be a charitable ground or purpose only.
3. Prizes shall be paid in kind only.
4. Total value of all prizes shall not be less than 50% of total value of ticket printed.
5. The applicant shall deposit to the Director, 25% of value of prizes by means of call deposit duly pledged in favour of Director, Institutional Finance & State Lottery as security deposit before issuing permission.
6. The applicant shall deposit a fee to the Government at the rate of 1% of total value of the scheme credited into the Treasury under the head "0075-Misc.Genl. Services, 103-State Lotteries" in favour of the Director, Institutional Finance & State Lottery. The original copy of treasury challans should be submitted to the Director, Institutional Finance & State Lottery before issue of permission.
7. Drawal of result shall be conducted under the supervision of the Director or his representative in the presence of two Judges nominated by the Government.
8. No extension of time of draw of the result shall be granted after marketing the tickets.
9. The statement of disbursement of prizes to the winners should be submitted to the Director, Institutional Finance & State Lottery within 60 days after the draw date.
10. Government permission No. and date should be printed at the back of the tickets.
